Board President Cara Mohr called the meeting to order at 7:02 p.m.
APPROVAL OF MINUTES

There was an $\$ 850$ expense out of the PE account that was for hockey sticks that had previously been approved and just
cashed recently. All schools in the district using the same Financial report. The goal for these categories is to have a starting and working budget for next year.
